Project Location (include county): The project is located in unnamed tributaries to Morrison Creek, in the County of Sacramento, State of California; Latitude 33°36' 26.0", Longitude 121°11' 59.8" within Section 10, Township 8 North, Range 7 East, in U.S. Geological Survey map Buffalo Creek. Assessor's Parcel Number 067-0040-017, 0067-0040-018, and 067-0040-017-026.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Amendment 1 to the Streambed Alteration Agreement Notification Number 1600-2018-0212-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Lal Brothers, LLC.

Amendment 1 removes the requirement for compensatory mitigation at a specific mitigation bank.


This is to advise that CDFW, acting as a Responsible Agency, executed the above-mentioned Amendment 1 to Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the environmental impact report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was not adopted by CDFW for this project.
