Project Location/City/County: The project is located approximately 85 feet south from the intersection of Garden Highway and W Elverta Road, Sacramento, Sacramento County.

Project Description: Approval of Permit No. 19547, under California Code of Regulations, Title 23, Article 3, Section 6, for work within an adopted plan of flood control: To authorize an existing electrical pole, light pole and one overhead cable on the waterside of the left bank levee of the Sacramento river between station 255+00 and 256+00. The poles and the overhead cable were required to be installed during the construction of the Natomas Levee Improvement Program (NLIP) under Permit No. 18159-4 that was issued to Sacramento Area Flood Control Agency (SAFCA).

This is to advise that the Central Valley Flood Protection Board, as the **Responsible Agency**, approved the above described project on January 20, 2023 and made the following determinations regarding the above described project:
