Project Description: The University of California, Lawrence Berkeley National Laboratory (UC LBNL) proposes continued operation of the Lawrence Berkeley National Laboratory (LBNL or Berkeley Lab) Hazardous Waste Handling Facility (HWHF) under a renewed Hazardous Waste Facility Permit (HWFP). The facility has been operating at its current Building 85 complex location since 1997 under HWFPs issued by DTSC. The renewed 10-year permit would authorize the Berkeley Lab HWHF to continue to store and treat limited quantities of hazardous and mixed wastes.

This is to advise that the University of California (Lead Agency) has approved the above-described project on December 9, 2022 and has made the following determinations:

1. The project **will not** have a significant effect on the environment.
2. An Addendum No. 2 to the *1990 Construction of Replacement Hazardous Waste Handling Facility Final EIR* (SCH #89040416) **was prepared** for this project pursuant to the provisions of CEQA.
3. Mitigation measures **were not** made a condition of project approval.
4. A mitigation reporting or monitoring plan **was not** adopted for this project.
5. A statement of overriding considerations **was not** adopted for this project.
6. Findings **were** made pursuant to the provisions of CEQA.
