
Project Title: B.F. Sisk Safety of Dams Geotechnical Investigations Project California Endangered Species Act
 Incidental Take Permit No. 2081-2019-028-04 Minor Amendment 1 (Amendment)

Project Location: The Project is located adjacent to the B.F. Sisk Dam, an impoundment for the San Luis Reservoir,
 located 12 miles west of Los Banos, in Merced County, California.

Project Description: The Amendment changes the Project description to move nine test pits from one borrow area
 (Borrow Area 6), which previously proposed to conduct 19 test sites, to the second borrow area (Borrow Area
 12/14), which previously proposed to conduct five test pits; there is no change to the total number of test pits (24) or
 maximum disturbance area as originally proposed.

This is to advise that CDFW, acting as [the lead agency / a responsible agency] approved the above-
