The Department of Water Resources proposes to implement the Lake Perris Seepage Recovery Project to install an integrated recovery well system to collect State Water Project water that is currently seeping beneath Perris Dam. The recovery well system would include up to six water recovery wells and a conveyance pipeline connecting the wells to the Colorado River Aqueduct.
