**Project Title:** San Bernardino Countywide Plan

**Project Applicant:** County of San Bernardino

**Project Location:** Countywide

**Project Description:** The Countywide Plan (CWP) is a web based, comprehensive update of the County's 2007 general plan. The CWP is driven by the Countywide Vision, adopted in 2011. The project meets the California Government Code (GC 65302) requirements for a general plan. The project includes the following components that will be reviewed for recommendation by the Planning Commission and which will be acted upon for final action by the Board of Supervisors:

1. County Policy Plan – an update and expansion of the County's General Plan, including a new approach to county planning that includes all required elements of a general plan but also includes topics such as social services, healthcare services, public safety, and other regional county services provided in both incorporated and unincorporated areas. Note: the Housing Element and the Renewable Energy and Conservation Element were adopted in separate actions by the Board of Supervisors and are not being updated through the Countywide Plan. They will be incorporated into the CWP and CWP web site. The CWP includes a new Land Use Map as the County is moving from a one map to a two map (land use designation map and a zoning map) system and incorporating them as web maps available through the web site. The Zoning Map will be adopted separately after CWP adoption and with associated development code amendments.
2. County Business Plan – with governance policies, operational metrics, and implementation strategies that outline the County's approach to providing municipal services in the unincorporated areas and regional services for both incorporated and unincorporated areas.
3. Repeal of 14 Community Plans and recognition of 35 new Community Action Guides.
4. Certification of the Final Program Environmental Impact Report.
