### **EXTENSION OF PUBLIC COMMENT PERIOD FOR THE VETERANS INDUSTRIAL PARK 215 (VIP 215) PROJECT DRAFT ENVIRONMENTAL IMPACT REPORT (DRAFT EIR)**

The March Joint Powers Authority (March JPA) has extended the comment period on the Draft Environmental Impact Report (Draft EIR) for the Veterans Industrial Park (VIP) 215 Project (State Clearinghouse Number 2016081061). In accordance with the California Environmental Quality Act (CEQA), a Notice of Availability (NOA) for the Draft EIR was previously released on March 11, 2020, through which a 45-day comment period was established, thus allowing the public to provide comments on the Draft EIR until April 24, 2020. In order to provide the public with an additional opportunity to provide comments on the Draft EIR, the 45-day public comment period will now end on Monday, May 11, 2020.
