**NOTICE IS HEREBY GIVEN** that the Planning Commission of the County of San Bernardino, at its regular meeting on **Thursday, January 23, 2020** will conduct a public hearing to consider:

**Proposal:** Conditional Use Permit to construct a religious facility consisting of a 27,364 square-foot, two-story Youth Center/Gymnasium, recreational facilities, sports field, 41,037 square-foot, two-story assembly building with a maximum seating capacity of 600, and a 1,500 square-foot, two-story maintenance/caretaker unit, all to be constructed in two phases on a 13.6-acre portion of a 27.12-acre site.
