Project Title: The Moffett Park Green Link Bordeaux-Borregas Bridge Project (Project) (Lake or Streambed Alteration Agreement No. EPIMS-SCL-35688-R3)

Project Location (Santa Clara): The Project is located at Moffett Channel, in the City of Sunnyvale, State of California; Latitude 37.409338, Longitude -122.021643; Assessor's Parcel Number 110-25-040.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS-SCL-35688-R3), pursuant to Fish and Game Code section 1602, to the Project Applicant, Google LLC as represented by Parham Khoshkbari.

The Project is a pedestrian and bicycle crossing of the Santa Clara Valley Water District's (Valley Water) West Channel (Channel) connecting Green Link pathways on 1212 Bordeaux Drive and 1265 Borregas Avenue. The work will be conducted on the latter two properties, which are owned by Google LLC, as the Permittee, while the Bordeaux-Borregas Bridge (bridge) will span the Channel, which is on Valley Water property. The Project also includes a 450-linear-foot trail on the west levee of the Channel and installation of bridge abutment walls and several new flood protection walls.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on July 5, 2023, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project **will not** have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the environmental impact report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures **were** made a condition of CDFW's approval of the project.
4. A Mitigation Reporting or Monitoring Plan **was** adopted by CDFW for this project.
5. A Statement of Overriding Considerations **was not** adopted by CDFW for this project.
6. Findings **were** made by CDFW pursuant to California Code of Regulations section 15091.

The Final EIR prepared for the project is available to the general public at the office location listed above for the Lead Agency. CDFW's record of project approval as a Responsible Agency is available at CDFW's regional office.
