The proposal consists of: (1) removal of plans for an Administration Building; (2) a new interim 4,320 sq. ft. modular building for 100 high school students in the independent study program; and (3) the expansion of the existing parking area to include 18 additional spaces. The anticipated usage of the modular building is five years or until the permanent high school classrooms are constructed, whichever occurs first.
