**Project Title:** Segment Q Phase 1.1 Project (Streambed Alteration Agreement No. 1600-2018-0360-R2), Amendment 1

**Project Location (include county):** The project is located on unnamed tributaries to Steelhead Creek, in the County of Placer, State of California; within Sections 4, 5, 8, and 9 of Township 10N, Range 5E of the U.S. Geological Survey (USGS) 'Rio Linda' 7.5-minute topographic quadrangles, California; approximately centered on Latitude 38.745621°N, Longitude - 121.447294°W.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed an amendment of Streambed Alteration Agreement No. 1600-2018-0360-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Lennar Winncrest, LLC.

The amendment includes a modification of the project impact footprint based on engineering refinements made to the Palladay Road design, addition of a new drainage ditch within the development footprint, and corresponding updates to project maps. As a result, permanent impacts to aquatic features have been reduced from 6.684 acres to 6.452 acres.

This is to advise that CDFW, acting as a Responsible Agency, amended the above Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the environmental impact report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was not adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
