**Project Title:** Dyer Lane Easement Sewer, Maintenance Road, and Pump Station (Infrastructure Segment D) (Streambed Alteration Agreement Notification No. 1600-2018-0194-R2)

**Project Location (include county):** The project is located at unnamed tributaries to Dry Creek and Steelhead Creek, in the County of Placer, State of California; Sections 9-12, township 10N, Range 5E; U.S. Geological Survey (USGS) Rio Linda map, California; Assessor's Parcel Numbers (APN): 023-010-004-000, 023-200-008-000, 023-200-011-000, 023-200-015-000, 023-200-028-000, 023-200-068-000, 023-010-006-000, 023-200-009-000, 023-200-012-000, 023-200-017-000, 023-200-041-000, 023-010-014-000, 023-200-010-000, 023-200-013-000, 023-200-018-000, and 023-200-063-000.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has extended Streambed Alteration Agreement Notification Number 1600-2018-0194-R2, pursuant to section 1602 of the Fish and Game Code to the project Permittee, Placer Vineyards Central Group, LLC. The Permittee has requested, and CDFW has granted, a five-year extension pursuant to Fish and Game Code section 1605, subdivisions (b) and (d).

The project is a component of the Placer Vineyards Specific Plan (PVSP), a 5,230-acre specific plan project, which includes on- and offsite infrastructure elements. The Segment D Infrastructure Project (Segment D Project) is a 32.5-acre component of the PVSP Backbone Infrastructure, which includes onsite infrastructure elements required for the development of the PVSP, specifically, roadway improvements, force main sewer line, gravity sewer line, and a sewer pump station. The activities proposed within the larger 32.5-acre project boundary of Segment D Project area, for which immediate authorization is sought by this Agreement, are limited to the installation of a sewer lift station, force main sewer line, gravity sewer line, maintenance road, and culverts associated with the maintenance road.

**Notice of Determination****- 2 -**

This is to advise that CDFW, acting as a Responsible Agency, extended the above Streambed Alteration Agreement extension on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the environmental impact report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was not adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were made by CDFW pursuant to California Code of Regulations section 15091.
