Project Title: Maple Lane Drainage Routine Maintenance (Lake or Streambed Alteration Agreement No. EPIMS-SBR-52712-R6)

Project Location (San Bernardino County): The Maple Lane Drainage Routine Maintenance Project (Project) is within an unnamed tributary to Baldwin Lake, in the County of San Bernardino, State of California; Latitude 34.261214, Longitude -116.825705; Assessor's Parcel Number [APN] 0312-421-43-0000. The drainage begins approximately 0.14 miles south of the intersection of Maple Ridge Drive and Maple Lane. It runs adjacent to Maple Lane and proceeds north to the southeast corner of the intersection of E. Big Bear Boulevard and Maple Lane.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS-SBR-52712-R6), pursuant to Fish and Game Code section 1602, the project Applicant, Theresa Sims/San Bernardino County Flood Control District.

The project is limited to the routine maintenance of Maple Lane Drainage. This road-adjacent drainage is an earthen channel that contains no levee and no adjacent access roads. Routine maintenance activities will be limited to the following: Obstruction Removal, Minor As-Needed Repairs, Vegetation Management, Chain link fence repairs, and Graffiti removal.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on May 7, 2025, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

- 1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
- 2. CDFW considered the **Mitigated Negative Declaration** prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
- Mitigation measures were made a condition of CDFW's approval of the project.
