PROJECT DESCRIPTION: The State Water Resources Control Board (State Water Board) is a Responsible Agency for the Project. The State Water Board's Drinking Water State Revolving Fund (SRF) Program is financing the Project. The Project includes a 12-inch, approximately 7,920-foot mainland extension pipeline, from the District's existing system at Comanche Drive and Sunset Blvd to the Son Shine Properties Water System. The water system consolidation will include installation of new fire hydrants, gate valves, air release valves, and metered services along the pipelines. In addition, the Project will involve a welded steel storage tank, hydropneumatics tank, booster pumping station, site piping, electrical controls, site fencing, and landscaping to lift the water from the District system to the Son Shine Properties area.

PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT: The State Water Board has approved SRF financing for the Project described above on July 7, 2020. The State Water Board has made the following California Environmental Quality Act (CEQA) determinations regarding the Project:

1. The Project will not have a significant effect on the environment.
2. A Mitigated Negative Declaration was prepared and adopted for the Project pursuant to the provisions of CEQA.
3. Mitigation measures were made a condition of approval of the Project.
4. A mitigation monitoring and reporting plan/program was adopted for the Project.
5. A Statement of Overriding Considerations was not adopted for the Project.
6. Findings were not made pursuant to CEQA Guidelines section 15091.
