Project Title: County Road 29 at Dry Slough Bridge Replacement (Lake or Streambed Alteration Agreement No. 1600-2020-0232-R2)

Project Location (include county): The project is located at the Dry Slough Bridge on County Road 29, in the County of Yolo, State of California; Latitude 38.5907°, Longitude -121.816169°; in Section 25, Township 9N, Range 1E, U.S. Geological Survey (USGS) map 'Merritt', Mt. Diablo Meridian; Assessor's Parcel Numbers (APNs) 040-170-009 and 040-200-029.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2020-0232-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, the Yolo County Department of Community Services, as represented by Darlene Comingore.

The project is limited to the replacement of the existing Dry Slough Bridge on Country Road 29 with a wider bridge that satisfies current width standards.

The existing 51.8-foot-long bridge is comprised of a single span reinforced concrete T-beam superstructure supported by end diaphragm abutments on unknown foundations. The proposed replacement bridge will span the slough with a single span and will be approximately 60 feet long and 40 feet wide, with two 12-foot lanes, 4-foot shoulders, and 4-foot graded aggregate base shoulder backing. The bridge foundations will consist of driven Caltrans Class 140 (Alternative W) 14-inch diameter steel pipe piles. The bridge and roadway embankment adjacent to the Slough will be protected with rock slope protection over slope protection fabric.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
