Project Title: Landry Pond Maintenance Project (Lake or Streambed Alteration Agreement No. EPIMS-MEN-10716-R1)

Project Location (include county): The project to be completed is located within the Eel River watershed, approximately one (1) mile southeast of the town of Laytonville, County of Mendocino, State of California. The project is located in Section 7, T21N, R14W, Mt. Diablo Base and Meridian; in the Laytonville U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-10716-R1, pursuant to Section 1602 of the Fish and Game Code to Mr. Cavin Landry.

The project is limited to one (1) encroachment. Encroachment 1 includes routine maintenance of an existing pond, which may involve manual maintenance of the pond inlet and outlet culverts. Water from the pond is not diverted for consumptive use. Maintenance involving the use of heavy equipment and/or replacement of culverts is not authorized by this Agreement.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
