Project Title: Martin Stream Crossing (Lake or Streambed Alteration Agreement No. EPIMS-MEN-04195-R1)

Project Location (include county): The project to be completed is located within the Eel River watershed, approximately 7 miles east of the town of Willits, County of Mendocino, State of California. The project at 18759 Scenic Drive, Redwood Valley; Assessor's Parcel Numbers 107-051-02-05, 108-212-13-05, and 108-213-09-05; latitude 39.39139 N and longitude 123.21005 W at the site of the stream crossing.

Project Description: The project is limited to 1 encroachment. Work for this encroachment will include excavation, removal of the culvert, replacement with a new properly sized culvert, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
