Project Title: Pena Stream Crossings (Lake or Streambed Alteration Agreement No. EPIMS-MEN-08790-R1)

Project Location (include county): The project to be completed is located within the Eel River watershed, approximately 2 miles southeast of the town of Willits, County of Mendocino, State of California. The project at 5730 Ridgewood Rd, Willits; Assessor's Parcel Numbers 108-182-23-00 and 108-182-17-00; latitude 39.39637 N and longitude 123.27590 W and 39.40015 N and 123.28179 W at the center of the parcels, respectively.

Project Description: The project is limited to 15 encroachments. Eleven encroachments are to upgrade undersized culverts. Work for these encroachments will include excavation, removal of the culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. The other 4 encroachments are for maintenance on properly sized culverts.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
