Project Title: Coombs Water Diversion Project (Lake or Streambed Alteration Agreement No. 1600-2020-0188-R1)

Project Location (include county): The project to be completed is located within the Eel River watershed, approximately one (1) mile southeast of the town of Piercy, County of Mendocino, State of California. The project is located in Section 6, T24N, R17W, Mt. Diablo Base and Meridian; in the Piercy U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2020-0188-R1, pursuant to Section 1602 of the Fish and Game Code to Mr. Bart Coombs.

The project is limited to one (1) encroachment (Table 1). Encroachment 1 is for water diversion from unnamed spring, tributary to South Fork Eel River. Water is diverted for domestic, irrigation and industrial purposes.

Work for the water diversion will include replacement of an existing spring box, and use and maintenance of the water diversion infrastructure. New water diversion infrastructure will continue to divert water via gravity.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).
