Project Title: Nicoll Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2020-0329-R1)

Project Location: The project is located within the Outlet Creek watershed, approximately 2.5 miles North of the town of Willits, County of Mendocino, State of California; Section 13, Township 19N, Range 14W, Humboldt Base and Meridian, in the Willits U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 037-100-64; latitude 39.4945N and longitude 123.3727W at Crossing 1.

Project Description: The project is limited to two (2) encroachment(s). Both encroachments are to upgrade failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
