Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-02750-R1, pursuant to Section 1602 of the Fish and Game Code to Mr. Corey Waxman.

The proposed project is limited to maintenance and repair of 4 existing culverts on tributaries to Robinson Creek. The agreement only covers maintenance of the existing culverts and does not include new construction or diversion of water from the property. Any diversion may require separate authorization. The culvert maintenance is associated with a commercial cannabis site.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
