Project Title: DeMello Culvert Maintenance (Lake or Streambed Alteration Agreement No. EPIMS-MEN-11450-R1)

Project Location (include county): The project is located near unnamed tributaries to Feliz Creek in the Russian River watershed, in the County of Mendocino, State of California; Latitude 38.983956, Longitude, -123.205701, 12950 Eagle Rock Road, Ukiah, CA, zip 95482; Assessor's Parcel Number 047-060-24-00.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-11450-R1, pursuant to Section 1602 of the Fish and Game Code to Mr. Ricardo DeMello.

The proposed project is limited to maintenance of two existing culverts on tributaries to Feliz Creek. Culverts are located at Lat/ Log 38.983956, -123.205701 and 38.986086, -123.208025. The agreement only covers maintenance of the existing culverts and does not include diversion of water from the property. Any diversion may require separate authorization. The culvert maintenance is associated with a commercial cannabis site.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
