Project Title: Culvert Replacements. Lake or Streambed Alteration Agreement No. EPIMS-MEN-05640-R1C

Project Location (include county): The project to be completed is located within the Middle Fork Eel River watershed, approximately 9.5 miles east of the town of Covelo, County of Mendocino, State of California; Section 27, T23N, R11W, Mt. Diablo Base and Meridian, in the Newhouse Ridge U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 032-291-02; latitude 39.8233 N and longitude -123.0767 W at the first stream crossing (Culvert-A).

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-05640-R1C, pursuant to Section 1602 of the Fish and Game Code to Alexandra Collins-Del Sordo.

The project is limited to 5 encroachments to upgrade undersized stream crossings. Work for these encroachments will include excavation, removal of the undersized crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described projects and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
