Project Title: Rosen Stream Crossing Project (Lake or Streambed Alteration Agreement No. EPIMS-21863-R1)

Project Location (include county): The project to be completed is located within the Russian River watershed, approximately 6 miles northeast of the City of Ukiah, County of Mendocino, State of California. The project is located in Section 24, T16N, R12W, Mt. Diablo Base and Meridian; in the Ukiah U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-21863-R1, pursuant to Section 1602 of the Fish and Game Code to Lawrence Rosen. The project is limited to two (2) encroachments. The encroachments are for manual routine maintenance of two existing culverted stream crossings.
