Project Title: Hagerty Dock Improvement Project (Lake or Streambed Alteration Agreement No. 1600-2019-0766-R1)

Project Location (include county): The project is located within the Tomki Creek watershed, approximately 7 miles northeast of the town of Willits, County of Mendocino, State of California; Assessor's Parcel Number 108-191-30; latitude 39.4526 N and longitude 123.2308 W.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2019-0766-R1, pursuant to Section 1602 of the Fish and Game Code to Mr. Scott Hagerty.

The project is limited to one encroachment for the installation of three additional supporting-piers for an existing dock on an impoundment of an unnamed tributary to Scott Creek. Installation shall occur during the dry season, when no water is present in the work area. Work for this encroachment will include digging and removal of spoils from the bank, placement of the footings and posts, cleanup and removal of all construction waste and debris, and erosion control. Work will be performed in accordance with California Stormwater BMP Handbook.
