Project Title: Moore Stream Crossings Project (Streambed Alteration Agreement No. 1600-2018-0176-R1)

Project Location: The project to be completed is located within the Mitchell Creek watershed, approximately 2.6 miles east of the locality of Caspar, County of Mendocino, State of California. Assessor's Parcel Number 019-370-19; latitude 39.3728 N and longitude -123.7651 W.

Project Description: The project is limited to 4 encroachments for upgrading or decommissioning of steam crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. Alternatively, Permittee may choose to decommission the stream crossings and restore the stream channel.

Determination: This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
