Project Title: Collin Remediation Project (Lake or Streambed Alteration Agreement No. EPIMS-15885-R1)

Project Location (include county): The project is located within the Russian River watershed, approximately 8 miles northeast of the City of Ukiah, County of Mendocino, State of California. The project is located in Section 12, T16N, R12W, Mt. Diablo Base and Meridian; in the Redwood Valley U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-15885-R1, pursuant to Section 1602 of the Fish and Game Code to Eric Collin.

The project is limited to one (1) encroachment. The project is in response to a Notice of Violation (NOV) that was issued following a site inspection. In response to the NOV, a remediation plan was developed. Trash and refuse areas were cleaned up and sediment and nutrient pollution sources were removed.
