Project Title: Souza Stream Crossing Decommissioning Project (Lake or Streambed Alteration Agreement No. EPIMS-MEN-22121-R1C)

Project Location: The project to be completed is located within the Orrs Creek watershed, approximately two miles northeast of the town of Ukiah, County of Mendocino, State of California. The project is located in Section 09, T15N, R12W, Mt. Diablo Base and Meridian; in the Ukiah U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 178-140-06-00; latitude 39.1747 N and longitude 123.1882 W at the first stream crossing decommissioning.

Project Description: The project is limited to two (2) encroachments. Both encroachments are for the decommissioning and revegetation of stream crossings.


