**Project Location (include county):** The project is located within the Russian River watershed, approximately 0.7 miles south of the town of Potter Valley, County of Mendocino, State of California; Section 20, T 17N, R 11W, Mt. Diablo Base and Meridian, in the Potter Valley U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Numbers 175-110-04, 175-140-08, and 175-140-09; latitude 39.3121 N and longitude 123.1115 W at the stream crossing.

**Project Description:** The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-16139-R1C, pursuant to Section 1602 of the Fish and Game Code to John Mulvaney.

The project is limited to one encroachment. The proposed encroachment is to upgrade a failing and undersized stream crossing. Work for this encroachment will include excavation, removal of the failing crossing, replacement with a new properly sized crossing, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

Project activities at the stream crossing shall require a pre-construction survey by a Designated Biologist only if surface water is present one week before construction or becomes present during construction.
