Project Title: Murray Stream Crossings Project or Streambed Alteration Agreement No. EPIMS-MEN-08564-R1C

Project Location: Eel River watershed, approximately 8 miles west of the town of Willits, County of Mendocino, State of California. The project is located in Section 32, T19N, R12W, Mount Diablo Base and Meridian; in the Foster Mountain U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 037-340-14; latitude 39.4582 N and longitude -123.2184 W at the first stream crossing (STX-1).

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-08564-R1C, pursuant to Section 1602 of the Fish and Game Code to Kenneth Murray.

The project is limited to seven (7) encroachments. Five encroachments are for upgrading failing and undersized culverts, two encroachments are for low water crossings. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized culverts where applicable, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

Vehicles shall not be operated on low water crossings/ rocked fords when water is present.
