Project Title: Carpenter Stream Crossings Project or Streambed Alteration Agreement No. EPIMS-MEN-12389-R1C

Project Location: Eel River watershed, approximately 6.5 miles southwest of the town of Laytonville, County of Mendocino, State of California. The project is located in Section 10, T20N, R14W, Mount Diablo Base and Meridian; in the Longvale U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Numbers 036-184-02 and 36-181-07; latitude 39.6060 N and longitude -123.4070 W at the first stream crossing (STX-1).

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-12389-R1C, pursuant to Section 1602 of the Fish and Game Code to Zach Carpenter.

The project is limited to 2 encroachments for upgrading failing and undersized culverts. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
