**Project Title:** Arise Farms Culvert Replacement or Streambed Alteration Agreement No. EPIMS-MEN-16119-R1C

**Project Location:** Salt Hollow Creek watershed, approximately 3 miles East of the town of Redwood Valley, County of Mendocino, State of California; Section 14, T16N, R12W, Mt. Diablo Base and Meridian, in the Ukiah U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 176-080-23; latitude 39.2471 N and longitude - 123.1568 W at the stream crossing.

**Project Description:** The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-16119-R1C, pursuant to Section 1602 of the Fish and Game Code to Joseph Mathaisell.

The project is limited to 1 encroachment. The encroachment is to upgrade an undersized stream crossing. Work for this encroachment will include excavation, removal of the failing crossings, replacement with new properly sized crossing, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
