Project Title: Berkowitz Stream Crossings Project. Lake or Streambed Alteration Agreement No. EPIMS-MEN-27423-R1C

Project Location (include county): The project to be completed is located within the Eel River watershed, approximately 5.8 miles northeast of the City of Willits, County of Mendocino, State of California. The project is located in Section 22, T 19N, R 13W, Mt. Diablo Base and Meridian; in the Willits U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 037-300-04-05; latitude 39.4801 N and longitude 123.2978 W at the first stream crossing (Culvert 1).

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-27423-R1C, pursuant to Section 1602 of the Fish and Game Code to Raam Berkowitz.

The project is limited to three encroachments. The three proposed encroachments are to upgrade existing culverts. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
