Project Title: Rivers Stream Crossing Projects (Lake or Streambed Alteration Agreement No. EPIMS-MEN-24677-R1C)

Project Location (include county): The project to be completed is located within the Upper Tomki Creek watershed, approximately 8.7 miles north of the town of Willits, County of Mendocino, State of California. The project is located in Section 6, T19N, R13W, Mt. Diablo Base and Meridian; in the Willits Ridge U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 056-420-05-00; latitude 39.5328 N and longitude 123.3529 W at the first stream crossing.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-24677-R1C, pursuant to Section 1602 of the Fish and Game Code to Alexis Rivers.

The project is limited to two (2) encroachments. Both proposed encroachments are to upgrade existing culverts. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, maintenance of inlet and outlet accumulated sediment, and rock armoring as necessary to minimize erosion.
