Project Title: Alvarez Stream Crossings, Bank Stabilization, and Remediation Project or Streambed Alteration Agreement No. EPIMS-MEN-29421-R1C

Project Location: The project to be completed is located within the Upper Eel River watershed, approximately 5.8 miles north of the town of Redwood Valley, County of Mendocino, State of California. The project is located in Section 32, T18N, R12W, Mt. Diablo Base and Meridian; in the Redwood Valley U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 107-053-30-00; latitude 39.37472 N and longitude 123.20981 W at the first stream crossing (SC-1).

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-29421-R1C, pursuant to Section 1602 of the Fish and Game Code to Armando Alvarez.

This Agreement relies on the Notification materials and a CDFW search warrant inspection on April 15, 2021. The project is limited to three (3) encroachments. Encroachments 1 and 2 are to upgrade existing culverts. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. Encroachment 3 is to remove debris and reestablish the stream through the previously graded cultivation site.

This is to advise that CDFW, acting as [] the Lead Agency / [X] a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

- 1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
