**Project Title:** Hucek Stream Crossing Project, Lake or Streambed Alteration Agreement No. EPIMS-MEN-39623-R1C

**Project Location:** The project to be completed is located within the Navarro River watershed, approximately 3 miles southeast of the town of Comptche, County of Mendocino, State of California. The project is located in Section 15, T16N, R15W, Mt. Diablo Base and Meridian; in the Navarro U.S. Geological Survey 7.5-minute quadrangle.

**Project Description:** The California Department of Fish and Wildlife has executed Lake or Streambed Alteration Agreement number EPIMS-MEN-39623-R1C, pursuant to Section 1602 of the Fish and Game Code to Jacob Hucek.

The project is limited to two (2) encroachments. Encroachment 1 (SC 3) is for maintenance and use of an existing pedestrian and ATV bridge. Encroachment 2 (SC 4) is for maintenance and use of an existing 24-inch diameter stream crossing culvert.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
