Project Location: The project to be completed is located within the Upper Russian River watershed, approximately 10 air miles southeast of the town of Ukiah, County of Mendocino, State of California. The project is located in Section 36, Township 14N, Range 12W, Mt. Diablo Base and Meridian; in the Purdys Gardens U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 047-310-13; latitude 39.02178 N and longitude 123.12390 W at the first stream crossing (STX-1).

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-37509-R1C, pursuant to Section 1602 of the Fish and Game Code to Pamela Whiting.

The project is limited to two (2) encroachments. The first encroachment (STX-1) is to monitor and maintain an existing stream crossing. Work for this encroachment will include monitoring and maintenance of the crossing and the roadside ditch that contributes flow to the crossing from above, and rock armoring as necessary to minimize erosion. The second encroachment (STX-2) is to upgrade an existing culvert. Work for this encroachment will include excavation, removal of the existing culvert, replacement with a new properly sized culvert, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
