Project Title: Lindley Stream Crossing Project, or Lake or Streambed Alteration Agreement No. EPIMS-MEN-49051-R1C

Project Location: The Project to be completed is located within the Big-Navarro-Garcia River watershed, approximately 2.5 miles west of the town of Boonville, County of Mendocino, State of California. The Project is located in Section 9, Township 13N, Range 14W, Mt. Diablo Base and Meridian; in the Zeni Ridge U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 029-590-02-05; latitude 38.99941 N and longitude 123.41159 W at the stream crossing (SC-1).

Project Description: The California Department of Fish and Wildlife has executed Lake or Streambed Alteration Agreement number EPIMS-MEN-49051-R1C, pursuant to Section 1602 of the Fish and Game Code to Robin Lindley.

The Project is limited to one (1) encroachment to upgrade an existing culvert. Work for this encroachment will include excavation, removal of the existing culvert, replacement with a new properly sized culvert, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

The Notification also disclosed a well located at 38.99805, -123.41296 as the water source for cannabis irrigation.
