Project Title: Seidell Stream Crossing Project (Lake or Streambed Alteration Agreement No. 1600-2018-0547-R1)

Project Location (include county): The project to be completed is located within the Albion River watershed, approximately 3 miles southeast of the town of Albion, County of Mendocino, State of California. The project is located in Section 25, T16N, 17W, Mount Diablo Base and Meridian; in the Elk U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2018-0547-R1, pursuant to Section 1602 of the Fish and Game Code to Mr. Joseph Seidell.

The project is limited to one (1) encroachment. Encroachment 1 is for replacement of an undersized culvert. Work for this encroachment will include excavation, removal of the old culvert, replacement with new properly sized culvert, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

The notification also disclosed a well as the source of water for the property.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.

2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
