Project Title: Wolfe Absolutely Organic Water Diversion Project (Lake or Streambed Alteration Agreement No. 1600-2017-0836-R1)

Project Location (include county): The project is located approximately 1.2 miles northeast of the town of Branscomb; affecting one unnamed tributary to the Eel River in the County of Mendocino, State of California; Sections 23 and 24, Township 21N, Range 16W; Mt. Diablo Base and Meridian, in the Cahto Peak, Calif. 7.5-minute quadrangle, U.S. Geological Survey (USGS) map.

Project Description: The project consists of one encroachment(s): The encroachment is for water diversion from an unnamed tributary to Mud Creek. Water is diverted for irrigation use. Work for the water diversion will include use and maintenance of the water diversion infrastructure and ensuring the infrastructure meets the conditions in this agreement. The Notification discloses a groundwater well of an unknown depth pumping water at an unknown rate for irrigation use.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
