Project Title: Butler Diversion Project (Lake or Streambed Alteration Agreement No. 1600-2018-0404-R1)

Project Location: The project to be completed is located within the Russian River watershed, approximately 4 miles north and west of the town of Redwood Valley, County of Mendocino, and State of California. The project is located in Section 12, T16N, R12W, Humboldt Base and Meridian; in the Redwood Valley U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 176-090-17-00; latitude 39.2532 N and longitude -123.1458 W at the point of diversion (POD).

Project Description: The project is limited to 1 encroachment (Table 1). The encroachment is for water diversion from an unnamed spring. Water is diverted from a cistern to storage for domestic household and cannabis cultivation use. Work for the water diversion will include use and maintenance of the water diversion infrastructure.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
