Project Title: Sussman Water Diversions Project (Lake or Streambed Alteration Agreement No. 1600-2017-0837-R1)

Project Location: The project to be completed is located within the Eel River watershed, approximately 11.5 miles east of the town of Willits, County of Mendocino, State of California. The project is located in Section 19, T18N, R11W, Mount Diablo Base and Meridian; in the Foster Mountain U.S. Geological Survey 7.5-minute quadrangle; Mendocino County Assessor's Parcel Number 171-060-03; latitude 39.40858 N and longitude 123.12651 W at the first point of water diversion.

Project Description: The project is limited to two encroachments. The two encroachments are for water diversion from Hale Creek and the Eel River. Water is diverted for domestic use. Work for the water diversion will include use and maintenance of the water diversion infrastructure.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
