Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2020-0035-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Sierra Vista Communities, LLC.

The project consists of several modifications to the bed, banks, channel, and floodplain of Curry Creek and its associated habitats as part of the construction of a mixed-use residential development and associated infrastructure project within the Sierra Vista Specific Plan. Activities covered by the Agreement include mass grading, construction of water quality features such as bio-retention basins and vegetated swales, two vehicle bridges, one pedestrian bridge, a maintenance road, a bike trail, utility crossings, and storm drains.
