Project Description: Modifications to the Carlsbad Desalination Project (CDP) approved intake and discharge system, including relocating (from on shore to submerged in the Agua Hedionda Lagoon) and altering the intake screening system; changes to the intake and discharge tunnels, the discharge pond and channel and auxiliary facilities; relocating the fish friendly intake pumping structure, and implementing a pilot intake program (pilot project) to test the design modifications effectiveness (proposed modifications) prior to finalizing the design and construction of the full scale intake facilities.

This is to advise that on March 21, 2019 the San Diego County Water Authority, as Lead Agency, approved the above-described project and has made the following determinations regarding the project:
