The project is located in the City of West Sacramento on Levee Road, between the Broadrick Boat Launching Facility and the I Street Bridge, on the right (west) bank levee of the Sacramento River.


Project Description:

Approval of Permit No. 19387, under California Code of Regulations, Title 23, Section 6, for work within an adopted plan of flood control, within a Regulated Stream (Table 8.1; Title 23, Div. 1, Article 8): To construct approximately 2,650-feet of Class 1 pedestrian/bike trail along the crown of the Sacramento River levee and extend the existing River Walk Trail adjacent to the Sacramento River channel. Improvements include a 12-foot wide paved pedestrian/bike path with 1-foot shoulders, pedestrian scale lighting, access gate with bollards, and signage posts along the crown of the levee; a 12-foot wide concrete path with 1-foot shoulders adjacent to the river; and a 12-foot wide concrete ramp that connects the levee crown with the River Walk Trail.

This is to advise that CVFPB, as the Responsible Agency, approved the above described project on May 22, 2020 and made the following determinations regarding the above described project:

1. The project [will / will not] have a significant effect on the environment (This determination is limited to effects within CVFPB's permitting jurisdiction as a responsible agency).
