Project Title: Routine Maintenance of Stream Channels and Drainage Facilities Project (Streambed Alteration Agreement No. 1600-2016-0034-R2)

Project Location: The project is located within the City of Elk Grove boundaries, covering 42 square miles and approximately 272 acres of natural creek and channels. The project occurs within the Florin, Elk Grove, Galt and Bruceville USGS quadrangles, between Latitude 38° 27' 10" to 38° 21' 49" N and Longitude 121 ° 29' 17" to 121° 16' 38" W.

Project Description: The California Department of Fish and Wildlife (CDFW) has amended Streambed Alteration Agreement number 1600-2016-0034-R2, pursuant to Section 1602 of the Fish and Game Code to the project Permittee, City of Elk Grove as represented by Sean Gallagher.

This third amendment to the Streambed Alteration Agreement expands Project Area to include Ehrhardt Channel (Shed A) and needed maintenance for the channel. The expansion of the Project Area is specific to CDFW's Streambed Alteration Agreement, and this amendment is intended to ensure the Streambed Alteration Agreement Project Area is consistent with the Project Area analyzed in the City of Elk Grove's Mitigated Negative Declaration.
