As evaluated in the 2014 WHWTP EIR, the District is implementing an expansion of the WHWTP design capacity from 4.5 MGD to 6.75 MGD. The expansion is necessitated by forecasted increases in treated water demand and the need for drought resilience in the District's service territory.
