Project Title: Petaluma River Flood Management – Denman Reach Phase 4 (Lake or Streambed Alteration Agreement No. 1600-2019-0021-R3)

Project Location: The project is located where Corona Street crosses over the Petaluma River, City of Petaluma, in the County of Sonoma, State of California.


Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2019-0021-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, City of Petaluma.

The project is limited to the excavation of approximately 6,150 cubic yards of sediment buildup along approximately 400 linear feet of Petaluma River channel centered on the Corona Road Bridge. Additionally, 475 cubic yards of riprap will be placed above and below the top-of-bank to protect the bridge abutments. The project also includes the creation of off-stream flood detention basins with three outlet pipes, each requiring 100 cubic yards of riprap.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on April 29, 2019 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.

The mitigated negative declaration / negative declaration prepared for the project is available to the general public at the office location listed above for the Lead Agency. CDFW's record of project approval as Responsible Agency is available at CDFW's regional office.
