Project Description: The Department of Toxic Substances Control (DTSC), approved a request, dated February 11, 2021, from RSR Corporation for temporary authorization to install and operate two Miscellaneous Units - a compression auger and centrifuge in the Battery Wrecker Building at Quemetco Inc. (EPA ID CAD 066233966) in accordance with Section 66270.42(e) of Title 22 of the California Code of Regulations. The purpose of the Miscellaneous Units is to eliminate free liquids from the hazardous waste that is stored on the floor of the Containment Building. On April 19, 2021, DTSC approved RSR Corporation's temporary authorization request to authorize the installation and operation of the two Miscellaneous Units for a period of 180 calendar days and will expire on October 15, 2021.

As Lead Agency under the California Environmental Quality Act (CEQA), DTSC approved the above-described project on April 19, 2021 and has made the following determinations:

1. The project will not have a significant effect on the environment.
2. An Environmental Impact Report was prepared for this project pursuant to the provisions of CEQA.
3. Mitigation measures were not made a condition of project approval.
4. A Statement of Overriding Considerations was not adopted for this project.
5. Findings were not made pursuant to the provisions of CEQA.
