**Notice of Intent to Adopt a Mitigated Negative Declaration****Central Valley Flood Protection Board
Sacramento County, California**

- Project Title:** Yuba River Basin, California Project – Marysville Ring Levee – Phase 2B & 3 (Project)
- Project Location:** The City of Marysville is located approximately 50 miles north of Sacramento, California in Yuba County and is surrounded by 7.5 miles of levee. These levees vary in height from 17 to 28 feet and protect the City of Marysville from flooding. Phase 2B and 3 are located along the existing levee south of 1st Street, north and west of the Yuba River, and east of A Street, 12th Street, and Hwy 20.
- Project Description:** The Central Valley Flood Protection Board (CVFPB) along with the U.S. Army Corps of Engineers (USACE) and Marysville Levee District (MLD) propose improvements to the Marysville Ring Levee (MRL). A previous Mitigated Negative Declaration (MND) was adopted in 2010 with the initial Environmental Assessment/Initial Study (EA/IS). Since 2010, additional design refinements have occurred, resulting in the need for a Supplemental EA/IS/MND. Construction of the Project is anticipated to take place in 2022 for Phase 3 and 2023 for Phase 2B.
- Public Meeting:** April 10, 2019 from 4 to 7 PM at Yuba County Government Center Marysville (915 8th Street, Marysville, California, 95901)

Following the requirements of the California Environmental Quality Act (CEQA), a Draft Supplemental EA/IS/MND has been prepared for this Project. The results of the Draft Supplemental EA/IS/MND indicate that mitigation measures would reduce all potential adverse impacts to less-than-significant levels. The CVFPB will consider adoption of the MND and approval of the Project during a regularly scheduled CVFPB meeting in late Spring or early Summer 2019:
